SECTION 7: Handling and storage

7.1 Precautions for safe handling

The product itself does not lead to emissions. However, during the waterproofing of surfaces using flame-distilled bitumen-polymer membranes, a limited airborne dispersion of potentially hazardous substances, including Polycyclic Aromatic Hydrocarbons (PAHs), may occur. If applied in confined spaces without adequate ventilation, the concentration of these harmful substances in the environment can reach levels that pose an inhalation risk to exposed personnel. Therefore, forced ventilation is necessary to ensure sufficient air exchanges, maintaining air quality and keeping emitted substance concentrations below their respective occupational exposure limits (T.L.V. as per ACGIH).
